They are less familiar, however, with the interpretive tools available for raising state constitutional claims and defenses. This presentation seeks to fill this gap by comparing the Ohio Bill of Rights with the U.S. Bill of Rights and the Fourteenth Amendment and by focusing on the unique procedural and methodological issues that arise when courts are asked to interpret the Ohio Constitution. In addition, the presentation will look at the opportunity that the Ohio Constitution provides to change fundamental law through direct democracy.
