

Legal Malpractice Defense Tips: The Requirement of Expert Testimony to Prove Causation

The use, or non-use as the case may be, of experts in legal malpractice litigation can be a valuable tool. Legal malpractice plaintiffs are constantly attempting to eek out every penny from the defendants while keeping costs at a minimum. One way of minimizing cost is by attempting to "shoestring" the litigation by dispensing with expert testimony to prove their case. Plaintiffs traditionally argued that expert testimony was unnecessary given that the blatant nature of the error was within the province of a lay person, and that expert testimony was simply not required under Ohio law on the element of proximate cause. As such, if the defendant attorney failed to file a claim within the statute of limitations, for example, but the ability to prove damages was nevertheless suspect, Plaintiffs were formerly able to skate past the summary judgment stage without an expert. As will be examined below, based upon a recent 6th District decision, legal malpractice plaintiffs must be prepared to present expert testimony on both the standard of care element of their case, as well as proximate cause. It is no longer sufficient to state that the defendant-attorney blew the statute of limitations; the plaintiff must still offer an expert opinion that the error proximately caused damages.

OACTA congratulates member Adam E. Carr of the Carr Law Office, LLC, in Hudson, Ohio. Mr. Carr's appellate win was featured in the July 17 *The Voice of the Defense Bar*, DRI's national electronic newsletter. Mr. Carr successfully convinced the Ninth District Court of Appeals to overturn an attorney fees award by the Barberton Municipal Court to a plaintiff based upon answers to requests for admission by prior defense counsel. At the underlying trial in a motor vehicle accident

case, the defense admitted negligence, but contested proximate cause and damages. The defendant did not appear at trial. The jury awarded total damages of \$7,131.31.

POLING LAW DEFENSE VERDICT IN ORANGE COUNTY, CALIFORNIA

Brant Poling and Doug Holthus of Poling Law recently successfully defended suit, in an action venued in the Superior Court of California (Orange County, Central District), brought against a California-based, long-term care/residential psychiatric care facility. Plaintiff, a former resident of Defendant's facility, alleged she had been raped by another resident. Plaintiff's pre-trial demand was Ten Million Dollars. Following a three-plus-week trial, and after nearly four days of deliberation, the jury returned a defense verdict.

CARTER STRANG HEADS SCHOLARSHIP PROGRAM FOR CLEVELAND SCHOOLS

OACTA member Carter Strang just completed his term as President of the Cleveland Metropolitan Bar Association. As CMBA president, Carter launched the Louis Stokes Scholars Program, which provides paid summer legal internships for college students interested in a legal career who are graduates of the Cleveland and East Cleveland Municipal School

Districts. The Stokes Scholars Program recently received the Expys Best New Internship Award and the NABE LexisNexis Community and Educational Outreach Award.

6th DISTRICT COURT OF APPEALS DECISION

On August 16, 2013, the Sixth District Court of Appeals agreed with Kurt Anderson and the firm of Davis & Young, affirming summary judgment granted to Erie County and its contractor, Herbst Excavating, LLC and finding that the county was entitled to immunity and the contractor was not negligent in the placement of barricades and signs at a bridge excavation. The decision,

Semprich v. County of Erie, Ohio, 6th Dist. No. E-12-070, 2013-Ohio-3561, was a rare instance in which the court agreed that the plaintiff was so negligent-by having a BAC of .265, having also consumed marijuana, and disregarding existing barricades, "Road Closed" signs, and surrounding darkness-that any reasonable juror would conclude that she caused her own injuries by walking through the construction site and falling into the creek.
